• **THURSDAY, AUGUST 23:** Together to End Solitary Confinement, , 6:30 PM, Worship Room, UUCSR, 48 Shelter Rock Road, Manhasset. Advocates for ending prolonged solitary confinement gather on the 23rd of every month, remembering those who are in segregated confinement 23 hours a day. On August 23 we will hold a vigil to call to mind those in solitary followed by a screening and discussion of the video, *Developing a Movement - End Mass Incarceration* with Jazz Hayden, Marc Lamont Hill, and Cornel West at Riverside Church. We will reflect on the intersections of race, mass incarceration, and solitary confinement. This program is free and open to the public.

• **THURSDAY, SEPTEMBER 6: Join fellow RSNS members and the Jewish Climate Action Network in a NYC march in support of the Global Summit.** Days before the Global Climate Action Summit convenes in San Francisco, people across the country and around the world will take to the streets demanding that our elected officials commit to the most far-reaching and effective policies possible. • **IS EVERY ELIGIBLE VOTER IN YOUR FAMILY REGISTERED TO VOTE?**

For example, *if your college-age child has not yet registered to vote*, a registration form can be downloaded at <https://www.nassaucountyny.gov/DocumentCenter/View/11812>.

Both pages of the form should be filled out and mailed to The Nassau County Board of Elections, 240 Old Country Rd., 5th Fl., Mineola, NY 11501.

You'll notice that Item 15 asks if an Absentee Ballot is needed. There's no need to check that box, since you can just download the Application for an Absentee Ballot when you're on the website to obtain registration materials.

Whether or not your child has already registered to vote, an Application for an Absentee Ballot must be requested. Here's the

Both pages of the form should be filled out and mailed to The Nassau County Board of Elections, 240 Old Country Rd., 5th Fl., Mineola, NY 11501.

At least 30 days before the election, an absentee ballot will be sent to your child. Many college kids do not normally have the stamp and envelope needed to mail back the ballot; we would be happy to provide them. If you send your child's name and school address to Social Action Committee member Roberta Handler (rih3@optonline.net), we will send a stamp, an envelope, and a reminder to vote about a month before the election.
